**Application Fee:** Permit must be accompanied by a \$25.00 non-refundable application fee. Please make checks payable to "State of Alaska." (Government agencies are exempt.) Incomplete applications will not be processed.

**Permit Fee & Revenue:** According to the fee schedule adopted under 17 ACC 42.125, Permittee shall pay a permit fee of \$250.00 annually as well as 10% of gross revenue.

**Certified Activity Reports:** In addition to the aforementioned fees, monthly submittals of Certified Activity Reports verifying gross sales and/or passenger numbers is required. CARs are due on or before the 20<sup>th</sup> day of every month, even if there is no activity. If CARs are not submitted on time, the Permittee shall pay, in addition to interest on all unpaid fees payable with that report, a late fee of \$30.00 for the first day late and \$15.00 per day thereafter for each report until the report is received. The fee will be assessed beginning the day after the CAR is due and will include the day it is received. If the due date falls on a weekend or a date that State's offices are closed due to holiday, the Permittee shall submit payment and a CAR by the end of the first workday following the weekend or holiday.

- I agree that this business may not operate at FAI unless all operational requirements are met.
- I agree that this business will not use the airport concourse to pick up or drop off vehicles.
- I agree that this business will operate in accordance with all applicable Alaska Statutes; Title 13 Public Safety, Chapter 04, Articles 1 through 270, and Title 17, Chapter 42, Article 1 of the Alaska Administrative Code; Fairbanks International Airport Operational Order 6.4; and any other applicable rules as may be issued or amended by Fairbanks International Airport.
