



Rural System Scope and Scale

- 247 DOT&PF owned/operated airports & seaplane bases
- 172 gravel & 47 paved airports; 27 Sea Plane Bases & 1 heliport
- 19 Part 139 certificated airports
- Primary access for 82% of Alaskan communities off the contiguous road system
- Rural System is not self sustaining; primarily funded by GF, some revenue via leases

Primary Revenues collected by Division of Statewide Aviation

Additional Revenue Sources collected by State of Alaska

- Aviation Gas Tax (4.7¢/gal) = \$0.5M
- Jet Fuel Tax (3.2¢/gal) = \$4.2M

Deadhorse Landing Fees

Extended operations needed due to increased airport operations

- Expanded operating hours, ARFF coverage, snow & ice control, daily maintenance
- 3 PCNs requested = \$570.7 increment (personnel services, travel, lodging)



Deadhorse Landing Fees

Proposal:

17 AAC 45 is amended by adding a new section to read:

17 AAC 45.128. Landing Fees.

- (a) The department will charge landing fees and an airport user shall pay for each landing at the Deadhorse Airport. The landing fee shall be \$2.00 per 1,000 pounds of CMGTW for an aircraft that weighs more than 6,000 pounds CMGTW.
- (b) Landing fee payments are due by the 15th of the month for the prior month's landings. Payments shall be accompanied by aircraft landing records specifying the aircraft identifier number, the aircraft's CMGTW, and date of all landings during the reported month.
- (c) Payment calculations shall be rounded up to the next highest 1,000 pounds of CMGTW. (Eff. ___/___, Register ____)
